





1. CREATION OF THE TRUST:

2. REGISTERED ADDRESS OF THE TRUST:

7. QUALIFICATION OF THE TRUSTEES shall be:

- a) The Trustees shall be any person who is competent to contract as per law.
- b) The Trustee shall not be adjudicated as insolvent.
- c) The Trustee shall not be persons promoting anti-social, anti-legal activities against law.
- d) The other provision for the qualification of the Trust shall be dealt with under section 10 of the Indian Trust Act 1882.

8. CESSATION OF TRUSTEESHIP:

A Trustee mentioned below shall cease to be the trustee of the Trust if:

- a) He resigns or death;
- b) He becomes insolvent;
- c) He is removed by the majority of the members of the, if it is found that the trustee(s) activities are detrimental or administration or funds of the Trust.



9. POWER OF THE BOARD OF TRUSTEES :

The Board of Trustees shall have the control and management of the Trust and exercise the following powers:

- a) To determine from time to time commence and to take up the objects and purposes for which the funds of the trust shall be used and allot and allocate to each of the objects such portion of the funds as they deem fit;
- b) To purchase and acquire any immovable property of any kind for this object of the Trust or as a source of income for the Trust;
- c) To incur all expenditure necessary as in their own opinion useful for carrying out objects and administration of the trust;
- d) To lease, mortgage of dispose of any property immovable property/properties belonging to the trust;
- e) To open one or more bank accounts of the trust with any bank or banks as the founder and trustees may deem fit and deposits monies of the Trust in the Bank;
- f) To employ staff of all kinds necessary and useful for carrying out the objects of the trust;
- g) To borrow for and on behalf of the trust with or without security from banks, governments, universities or any other government body/bodies both central and state;
- h) To incur such other items of expenditure as is necessary and incidental for carrying out the objects of trust;
- i) To institute, conduct, defend, compound, withdraw, compromise, adjust, refer to court or arbitration to do such things as are incidental and necessary, concerning the affairs of the Trust and to sign and verify vakalats, pleadings, affidavits and other power's;
- j) To delegate all or any of the power vested in the Trustees to any body' to frame rules, bylaws and other codes for the conduct of the affairs of the Trust and its transactions and establishing any committee;
- k) To accept contribution in case or in kind either by way of addition to the trust funds generally or for any one or more of the specified objects of the Trust;
- l) To establish as many committees for any purpose;
- m) The board of the trust is authorized to sue or to be sued on behalf of the Trust;

14. AUTHORIZED SIGNATORY IN OTHER MATTERS:

In the matters of above specified points other than 9,10,11,12 the "Founder of the Trust" shall be authorize to sign on behalf of the matters of the Trust.

15. APPLICATION OF INCOME AND TRUST FUND:

The Board of Trustee shall be empowered to invest the funds of the trust in movable or immovable properties, in such manner as they deem fit for the purpose of the objects of the trust provided that such investments shall be in accordance with the provision of section 13(1) read with section 11(5) of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to charitable Trusts.

16. DISSOLUTION:

On dissolution of the Trust, the net assets of the Trust shall be transferred to a trust having similar objects of this Trust.

17. PROCEEDING OF THE TRUST:

Any defect in the constitution of the Trust shall not be invalidate its proceedings.

18. AMENDMENTS:

While this trust shall be irrevocable the board may amend the class relating the membership and the management at year duly convened meeting of the board by a resolution passed by simple majority at least two weeks' notice had been given before.

If any alteration/ amendment where necessary, the same shall be effected through supplementary deed/deeds with the approval of commissioner of Income tax.




